

Privacy Notice (How we use pupil information)



We collect and use pupil information to enable us to run the school and provide education as permitted under:

- Article 6 (1) (c) of the General Data Protection Regulation which permits processing that is necessary for compliance with a legal obligation to which the data controller is subject;
- Article 6 (1)(e) which permits processing for tasks carried out in the public interest; and
- Article 9 (2)(g) which permits processing which is necessary for reasons of substantial public interest.

Under Section 537A of the Education Act 1996 we are also required to submit school census returns, including a set of named pupil records, and pupil information is collected and used for this purpose.

The categories of pupil information that we collect, hold and share include:

- Personal information (such as name, unique pupil number and address)
- Characteristics (such as ethnicity, language, nationality, country of birth and free school meal eligibility)
- Attendance information (such as sessions attended, number of absences and absence reasons)
- Assessment information (such as test results and attainment levels)
- Medical information (such as information about medical conditions the school needs to take into account or allergy information and details of medical practitioners involved in the child's care)
- Special educational needs information (such as reports of assessments carried out in school or by outside professionals and records of interventions provided in school)
- Exclusion / behavioural information
- Child protection and safeguarding information

Why we collect and use this information

We use the pupil data:

- to support pupil learning
- to monitor and report on pupil progress
- to provide appropriate pastoral care
- to assess the quality of our services
- to comply with the law regarding data sharing
- facilitate efficient communication with parents

Collecting pupil information

Whilst the majority of pupil information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the General Data Protection Regulation, we will inform you whether you are required to provide certain pupil information to us or if you have a choice in this.

Storing pupil data

We hold pupil data for periods in line with the recommendations made by the Institute for Records Management this includes:

Child Protection information – the date of birth of the child + 25 years

Special Educational Needs files, reviews and Individual Healthcare Plans – the date of birth of the child + 25 years

Who we share pupil information with

We routinely share pupil information with:

- schools that the pupil's attend after leaving us
- our local authority
- the Department for Education (DfE)
- the School Nursing Team and/or the NHS
- Safeguarding/Child Protection officers
- Third parties involved in school communication processes
- Suppliers and service providers (A full list is available upon request)

Why we share pupil information

We do not share information about our pupils with anyone without consent unless the law and our policies allow us to do so.

We share pupils' data with the Department for Education (DfE) on a statutory basis. This data sharing underpins school funding and educational attainment policy and monitoring.

We are required to share information about our pupils with the (DfE) under regulation 5 of The Education (Information About Individual Pupils) (England) Regulations 2013.

The National Pupil Database (NPD)

The NPD is owned and managed by the Department for Education and contains information about pupils in schools in England. It provides invaluable evidence on educational performance to inform

independent research, as well as studies commissioned by the Department. It is held in electronic format for statistical purposes. This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

We are required by law, to provide information about our pupils to the DfE as part of statutory data collections such as the school census and early years' census. Some of this information is then stored in the NPD. The law that allows this is the Education (Information About Individual Pupils) (England) Regulations 2013.

The department may share information about our pupils from the NPD with third parties who promote the education or well-being of children in England by:

- conducting research or analysis
- producing statistics
- providing information, advice or guidance

The Department has robust processes in place to ensure the confidentiality of our data is maintained and there are stringent controls in place regarding access and use of the data. Decisions on whether DfE releases data to third parties are subject to a strict approval process and based on a detailed assessment of:

- who is requesting the data
- the purpose for which it is required
- the level and sensitivity of data requested: and
- the arrangements in place to store and handle the data

To be granted access to pupil information, organisations must comply with strict terms and conditions covering the confidentiality and handling of the data, security arrangements and retention and use of the data.

Requesting access to your personal data

Under data protection legislation, parents and pupils have the right to request access to information about them that we hold. To make a request for your personal information, or be given access to your child's educational record, contact Joanna Loisel, the School Business Manager and you will be asked to fill in a Subject Access Request form.

You also have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed; and
- claim compensation for damages caused by a breach of the Data Protection regulations
